1 Developed Countries

1.1 Individual Members

Tier 1: “Basic Membership” Euro 25,00

Includes information about events/ workshops, access to newsletters, annual reports and IJHE

Tier 2: “Professional Membership” Euro 40,00

Includes “Basic Membership” and one online workshop (15,00 Euro), reduced fee for three more workshops (Euro 10,00/ workshop), access to certification application

Tier 3: “Comprehensive Membership” Euro 80,00

Includes “Basic Membership”, all workshops, access to certification application, reduced event fees for members, access to research round up, participation in UN activities

1.2 Student Members

Tier 1: “Basic Student Membership” Euro 25,00

Includes information about events/ workshops, access to newsletter, annual report and IJHE, and access to the International Junior Forum

Tier 2: “Young Researcher Membership” Euro 40,00

Includes “Basic Student Membership”, one workshop/ year (Euro 15,00), three more workshops/year with reduced fee (Euro 10,00) access to certification application, reduced fees for events, access to research round up, participation in UN activities

1.3 Organisations

“Organisational Membership” Euro 290,00

Includes Publication of international events & opportunities on the IFHE website, access to UN awards & calls (requires nomination by IFHE, public visibility as part of the global network.

**All members have a vote in the IFHE Council Delegates Assembly but,
only Tier 3 Individual members can be elected to the Executive Committee.**

2 Developing Countries

2.1 Individual Members

Tier 1: “Basic Membership” Euro 10,00

Includes information about events/ workshops, access to newsletters, annual reports and IJHE

Tier 2: “Professional Membership” Euro 15,00

Includes “Basic Membership” and one online workshop (15,00 Euro), reduced fee for three more workshops (Euro 10,00/ workshop), access to certification application

Tier 3: “Comprehensive Membership” Euro 30,00

Includes “Basic Membership”, all workshops, access to certification application, reduced event fees for members, access to research round up, participation in UN activities

For Tier 3 “Comprehensive Membership” IFHE offers a reduced membership fee of 25,00 Euro per year, when an advanced payment for 4 years is made.

2.2 Organisations

“Organisational Membership” Euro 290,00

Includes Publication of international events & opportunities on the IFHE website, access to UN awards & calls (requires nomination by IFHE, public visibility as part of the global network.

All members have a vote in the IFHE Council Delegates Assembly but, only Tier 3 Individual members can be elected to the Executive Committee.
